Request for Public Informational Meeting Dates

To Whom It May Concern:

Navigator Heartland Greenway, LLC ("Navigator") is requesting additional informational meetings for its Heartland Greenway project as set forth below. Recognizing the economic and environmental benefits that the project will deliver, several additional facilities have elected to participate in the project; this additional interest, as well as information gleaned from initial surveys, has resulted in changes and additions to the project route.

The vast majority of the route has not changed; thus, notice of the new informational meetings will be sent only to those persons identified in Board Rule 13.2(5) whose parcels may be affected by the additional or revised routes. The persons identified in Board Rule 13.2(5) who previously received mailed notice of the project and the informational meeting in their county will not receive a second mailed informational meeting notice unless they have additional parcels that are within the new notice corridors. Published notice of the informational meeting in each county will be made pursuant to Board Rule 13.2(5).

To assist the Board in scheduling the public informational meetings, Navigator proposes the following schedule, which is designed to best enable participation by avoiding the Iowa State Fair, the Labor Day holiday, and the fall harvest. Navigator has attempted to take into account the Board's public schedule and has grouped counties for ease of travel. Reservations have been made for the listed locations, which Navigator believes meet the requirements of the Board's rules. Navigator has also listed the estimated number of parcels crossed in each country listed, WiFi capabilities, ADA-compliance, and any COVID-19 measures, restrictions, or accommodations that, to our knowledge, are currently in place.
