Wolf Carbon Solutions US, LLC ("Wolf") has developed a proposal to build and operate a carbon capture pipeline system in Iowa and Illinois ("Mt. Simon Hub"). The project will capture carbon dioxide emissions from local facilities before it reaches the atmosphere, convert it to a liquid form, and transport it via pipeline to a permanent underground sequestration site within the Mt. Simon Sandstone saline reservoir in Illinois. Wolf is committed to transparent, two-way communication throughout this process and is enthusiastic about bringing the economic and environmental benefits of this carbon capture and storage project to Iowa.
