A Resolution Adopting the City of Oelwein's Official Position on the Navigator Heartland Greenway CO₂
Pipeline

WHEREAS, the threats to personal safety from the proposed Navigator Heartland Greenway pipeline would cause undue burdens on public safety from the City of Oelwein; and

WHEREAS, CO₂ is dangerous and can be toxic, causing sickness and death if released from a ruptured pipeline, and

WHEREAS, a dangerous pipeline presenting the risks such as the proposed Navigator Greenway CO₂ pipeline would present the need for additional emergency services, evacuation plans, disaster mitigation, and the accompanying budgetary expenses associated with those requirements, and


