WIND ON THE WIRES' COMMENTS ON PROCEDURAL SCHEDULE

COMES NOW Wind on the Wires' comments on the separate procedural schedules submitted by Staff of the Iowa Utilities Board ("IUB") and by Rock Island Clean Line LLC's (see Attachments A and B, respectively) and in response to the Iowa Utility Board's ("IUB") request, made at the scheduling conference held on July 11, that the parties provide written comments by 3pm central time, Friday, July 15, 2016.

Wind on the Wires comments on the proposed schedules are as follow:

1. The proposed schedules are largely similar on key dates, but differ on their level of detail: Rock Island's proposed schedule has a higher level of detail, including specificity and additional milestones than Staff's proposed schedule. Below is a chart providing a side by side comparison of the key milestones proposed by Staff and Rock Island, with key differences noted in red text:

- 2. Wind on the Wires will comment on the filing dates for Exhibit E, and the dates for filing intervenor testimony and briefs.
- 3. Wind on the Wires supports the date Rock Island has proposed for it to file its initial Exhibit E -- which is May 2017. The Iowa Utilities Board ("Board") should give Rock Island

the opportunity to ensure the initial Exhibit E filing is as accurate as can be. The additional time afforded Rock Island to prepare its Exhibit E will minimize delays that could be caused by documentation errors and prevent there being evidentiary arguments based on inaccurate data. This is a very long project -- over 500 miles in length, 370+ miles is within the state of Iowa -- that potentially touches thousands of properties. Given the length of this project, granting Rock Island until May 2017 to finish the outstanding property descriptions and eminent domain issues is prudent for the administrative efficiency of this hearing and still provides sufficient time for parties to submit testimony and briefs and the Board to render its decision prior to the May 2018 deadline.

- 4. The time needed for IUB staff to review Exhibit E is critical. If the comments do not provide sufficient guidance on the activities Staff and Rock Island need to perform and the time to perform those activities, the Board should consider directing Staff and Rock Island to meet and mutually agree upon a date for submission of Exhibit E. Once that date is established the Board should be able to define the remaining milestone dates.
- 5. Wind on the Wires recommends that all intervenors submit testimony on the same date, 4 to 6 weeks after Rock Island files its direct testimony. Four to six weeks gives expert witnesses time to prepare any new comments that we would want to present in response to Rock Island's testimony.
- 6. For initial and reply briefs, Wind on the Wires requests six to eight weeks post evidentiary hearing to prepare the initial brief, and four weeks to prepare the reply brief. This appears to be consistent with what Rock Island has proposed.

WHEREFORE, Wind on the Wires' respectfully requests the Iowa Utilities Board approve a schedule that is consistent with the recommendations set forth above.
