INTERPRETATION NO. IPL E2016-21 ALTERNATIVE ENERGY PRODUCTION RATE COMPLIANCE FILING

RE: Docket Nos. TF-2016-____

<u>Purpose</u>

The lowa Utilities Board (Board) issued an Order in Docket No. NOI-2014-0001 on July 19, 2016 (July 19th Order), requiring the lowa investor-owned utilities to file three-year net metering pilot tariffs. Coinciding with the filing of a new net billing tariff (Docket TF-2016-0321) the existing net metering tariff (AEP rate) will no longer be available to customers installing their own generation. Upon Board approval, this change will be effective January 1, 2017. The existing AEP rate will be closed to customers installing generation after the date. Any customer who submits a completed interconnection application prior to January 1, 2017 would be allowed to take service under the existing AEP rate. An existing AEP rate customer can opt for the new net billing tariff however it will not be allowed to return to the AEP rate in the future. Therefore, the AEP tariff sheets will be marked as "Frozen" and under the General terms section the rate will state that it is frozen to existing customers at existing locations.
