ORDER ACCEPTING WITHDRAWAL OF PETITIONS

(Issued December 23, 2016)

On November 6, 2014, Rock Island Clean Line LLC (Clean Line) filed with the Utilities Board (Board) 16 petitions for electric transmission line franchises in 16 different Iowa counties. Each petition was given a separate docket number, starting with Docket No. E-22123 and proceeding sequentially through Docket No. E-22138. On August 8, 2016, the Board issued an order creating a master docket, identified as Docket No. E-22248, to receive all pleadings, motions, and other filings that apply to all 16 dockets.

On December 22, 2016, Clean Line filed a "Withdrawal of Petitions for Electric Franchise) in the master docket. Clean Line says that the project it has proposed, a high voltage, direct current transmission line capable of delivering electric power from northwestern Iowa to Illinois and elsewhere, requires regulatory approval in both Iowa and Illinois. Clean Line says that in light of the timing of certain judicial review proceedings in Illinois and the statutory deadline for a decision in Iowa (prescribed by new Iowa Code § 478.6A, adopted May 27, 2016), Clean Line has decided to

withdraw all 16 of its petitions in Iowa. Clean Line says it will make a determination concerning any new filing in Iowa following resolution of the judicial review proceedings in Illinois.

The Board will accept Clean Lines' withdrawal of its petitions. In order to make the record in each docket complete, the Board will direct that this order be uploaded into the Board's electronic filing system in the master docket and in each of the 16 original dockets.
