ORDER GRANTING ADMISSION PRO HAC VICE

(Issued June 6, 2019)

On April 19, 2019, the Utilities Board (Board) issued an "Order Commencing Rule Making" in the above-captioned docket. To the Order, the Board attached a proposed "Notice of Intended Action" (NOIA), which included the Board's proposed amendments to 199 IAC chapter 17. On May 8, 2019, the NOIA was published in the Iowa Administrative Bulletin as ARC 4416C. The published NOIA provided notice that an oral presentation concerning this proposed rule making will be held from 9 to 11 a.m. on June 13, 2019.

On June 4, 2019, Attorney Andrew D. Cardon filed a "Request for Permission to Appear Pro Hac Vice" in the above-captioned proceeding on behalf of Interstate Power and Light Company (IPL). In support of his request, Mr. Cardon states he is an attorney employed by Alliant Energy Corporate Services, Inc. (Alliant), where he supports Alliant and its subsidiaries, including IPL. Mr. Cardon states he is admitted to practice law in the courts of Wisconsin and was previously admitted to practice law

in the Commonwealth of Virginia and the District of Columbia.¹ Mr. Cardon asserts that in February 2019 he submitted an Application for Admission Without Examination for admission to practice law in Iowa; however, as of June 4, 2019, his application for Iowa licensure remained pending.

Mr. Cardon further states he has not previously been denied admission pro hac vice in the state of Iowa, has not had admission pro hac vice revoked in the state of Iowa, and has not been formally disciplined or sanctioned by any court in the state of Iowa. Mr. Cardon acknowledges being familiar with the rules and standards of professional conduct, the disciplinary procedures for the state of Iowa, and the Board's procedures.

Mr. Cardon claims Michael S. Greiveldinger, a member in good standing with the lowa bar, sponsors his admission request. Mr. Cardon further states he complied with Iowa Rule of Court 31.14(11) by registering with the Iowa Office of Professional Regulation and paying the required fee.

Mr. Cardon's request complies with Iowa Administrative Code rule 199—7.4(8). Mr. Greiveldinger is an in-state attorney upon whom service may be made in all matters connected with this proceeding. The Board will grant Mr. Cardon's request for admission pro hac vice.

^{1.} Mr. Cardon states that in 2018 he voluntarily withdrew his licenses in the Commonwealth of Virginia and the District of Columbia because he was no longer practicing law in those jurisdictions.
