Dear Interested Party,

The U.S. Fish and Wildlife Service (Service) seeks to notify you of the availability of the final environmental impact statement (FEIS), draft record of decision (draft ROD), and habitat conservation plan (HCP) in support of an application from MidAmerican Energy Company (MidAmerican) for an incidental take permit for five covered species, including the federally endangered Indiana bat, federally threatened northern long-eared bat, and federally protected bald eagle. Also included in the permit would be the little brown bat and tricolored bat, which are not federally protected, but are included as covered species in the HCP. These documents are available online at https://www.regulations.gov (docket number FWS-R3-ES-2018-0037), at https://www.fws.gov/midwest/RockIsland/te/MidAmericanHCP.html, and in hard copy at the physical locations listed at the end of this letter. In addition, the Environmental Protection Agency is publishing a notice announcing the EIS, as required under the Clean Air Act, section 309 (42 U.S.C. 7609).

The FEIS and draft ROD were developed in compliance with the agency decision-making requirements of the National Environmental Policy Act (NEPA; 42 U.S.C. 4321 et seq.) and are based on the HCP as submitted by MidAmerican. We described, fully evaluated, and analyzed seven alternatives in detail in our 2019 FEIS. The draft ROD documents the rationale for our pending decision. The final ROD will be available on the Service's website (listed above) no sooner than 31 days after this notice.
