**ORDER SCHEDULING TECHNICAL CONFERENCE**

On May 27, 2020, the Utilities Board (Board) issued an order rejecting the proposed tariff filed by Prodigy Solutions, Inc. (Prodigy), and requiring Prodigy to file a revised tariff and a response to issues raised in the order. On June 25, 2020, Prodigy filed a revised tariff for Board review. Also on June 25, 2020, Prodigy filed a response to the issues raised in the May 27, 2020 order and a request for confidential treatment of certain information in the response.

The Office of Consumer Advocate (OCA), a division of the Iowa Department of Justice, filed an appearance and an objection in this docket. Prison Policy Initiative, Inc., has been granted intervention in this docket.

To allow for a full discussion of the revised tariff filed by Prodigy on June 25, 2020, the Board is scheduling a technical conference for 2 p.m. August 13, 2020. The agenda for the technical conference is included as Attachment A to this order and incorporated into this order by reference. The technical conference will be conducted electronically.
