RE: Notice of Study Area Boundary Recertification

Iowa Incumbent Local Exchange Carriers:

On June 16, 2021, the Iowa Utilities Board (IUB) recertified Incumbent Local Exchange Carrier (ILEC) study area boundaries with the Federal Communications Commission (FCC), pursuant to the FCC's May 11, 2021 Public Notice (DA 21-552), which states:

As required in the *Study Area Boundary Order*,¹ ILECs and state commissions that have voluntarily agreed to file study area boundary data on behalf of some or all ILECs operating within their jurisdictions (certifying state commissions) must review and recertify study area boundary data every two years.

Attached to this letter is the completed recertification form, along with a list of the study area codes, recertified with the FCC.
