As the daughter of an impacted landowner, I request you release the landowner lists for the Summit and Navigator pipelines.

Former Governor Terry Branstad recently sent a letter to Summit landowners advocating for the pipeline and specifically to smear the efforts of the Sierra Club in helping landowners gain more access to information on the true merits of these projects. It is noteworthy to state the lack of accountability, transparency and information provided by the pipelines, as overseen by the IUB, requires 3rd parties to assist in the full public debate of the merits of these projects.

Terry Branstad has been publicly named as "an advisor" to the Summit pipeline. Is that relationship an employment relationship, a 3rd party consultant relationship or is that a minority interest ownership relationship? What is Terry Branstad's exact involvement in this project and how/why was he privy to the landowner information? Without further information, I would state a 3rd party advisor role, as stated in newspaper articles, would mean Summit is already sharing the landowner list with external parties to advocate its own interests while the public is not privy to the same details. How is Terry Branstad's role here any different than the Sierra Club? He has access to this information but no one else does.

Release both landowner lists. Release the details of exactly how Terry Branstad was privy to this information and why, including his exact contractual and financial relationship to any of these projects. Without further information, it appears Summit has already broken its privacy vow and confidences. Without a full release of the landowner lists, the IUB is at risk of overseeing a process which will be characterized as lacking accountability and transparency and at its core appears to discriminate against the landowner. This is not good governance or public stewardship. Our concern is that, although we received a phone call from Navigator, we have not received any packet from them. The day of the Linn County meeting was when we received the phone call. It was last-minute notice. Now we have to try to catch up and get as much information as we can, but we still haven't received any paperwork from Navigator. When I called back to Navigator after they left a message, I was told that there were a lot of people in Linn County who hadn't received the packet. This is very concerning. (Are they really trying to let people know? If you don't know, you can't get to the meetings.)

An important thing is that we already have a pipeline going through our property. It goes through our timber and CRP field. We have this as a timber reserve and this pipeline has taken out a portion of our field. It looks like the new pipeline will go through the same timber and CRP field.

This pipeline looks like its going to go closer to our house. Safety is a real concern. We live in a rural area and it would take about 10 minutes for an emergency responder to get to our house. Our son actually volunteers with the Mount Vernon fire department, and he hasn't received any information about a CO2 and safety procedures. He lives next door to us and will be affected by the pipeline, but he hasn't received any information from Navigator, either.

We are nearing retirement and this pipeline is messing with the plans and dreams that we've made for forty years -- forty years working to build a future here on our century farm, which is almost now a heritage farm. Our grandson is the 6th generation to live on our family land here. We don't want him to inherit property with two pipelines running through it. Also, if they can do this, who's to say that a few years down the road that another company won't decide to install another pipeline here? And it goes on and on. We lost the beautiful land and scenic area that our ancestors worked so hard to steward for future generations.

Comments: I attended one of the Heartland Greenway meetings. I asked the utility board member if they would approve flow through pipeline before all renovation is complete. I feel all landowners should be contacted prior to approval for flow. We went through the Dakota pipeline project and had several issues a rise, the most significant was them driving across our tile lines after several inches of rain causing 2 foot deep ruts that crushed the majority of our 69 laterals. They were informed of this immediately and sent out a crew to dig up random lines to verify. They concluded they were in fact damaged. This was roughly the last half of October. I contracted our land agent, Rick Phlips, every week asking what there decision on how to fix and was. I was told next week he would know more. This went on all through October and into November. A week prior to calling him and I was told after Thanksgiving he would know more. I called again was told maybe next week he would know more. I kept calling every week and was told the same thing. We went into January and still no answers. Then Rick Philps wouldn't return my phone calls. I contacted the Utility board, they put me in contact with their attorney and he said "unfortunately nothing they could do since they approved the permit to pump crude". I contacted my attorney and she contacted the head of the project and after a heated exchange she was put in contact with the lowa attorney for this project. The time frame is now April. They finally asked what and how we wanted to fix our tile and we finally agreed on a settlement. But was to late to correct our issue by planting season. The county inspector told us there where several issues that were not addressed before the permit was a approved and they couldn't get them to take care of the issues. My frustration lies with the utility board, if they would have contacted every landowner to see if there was any unresolved issue prior to allowing the use of the pipeline I feel the pipeline company would have addressed the issues in a timely fashion. They openly admitted they were in the wrong but did nothing to fix the problem. My plea is to contact ALL parties involved BEFORE flow is approved.

We want to file an objection in an open docket against HLP-2021-0003 (Navigator CO2 Ventures LLC, Petition for a Hazardous Liquid Pipeline Permit). It is a dangerous pipeline with huge consequences to us as homeowners, whether in the towns or countryside. It would put our lives at risk as well as our animals. Who will profit and who has the risk of life or death? Pure liquid CO2 is an asphyxiant that can kill within 15 minutes. Also, we are adamantly against the use of eminent domain for the Navigator's private profit because Navigators profits or industry profits are NOT a public good.

At an informational meeting in Linn County on December 6, 2021 the spokesperson for Navigator said that sequestering the CO2 underground in Illinois is "green" and reduces the carbon footprint of ethanol plants here in Iowa. Hmmm, but what will the CO2 really be used for? Why is it going by pipeline to Illinois and not to a sequestration site right here in Iowa (which, according to scientists from the Iowa Geological Survey, has the same Mt. Simon formations)? Isn't it because the "industrial use" that Navigator's CO2, David Giles, mentioned at the Linn County public meeting on December 6th is actually enhanced recovery of fossil fuels? Illinois has fossil fuels—Iowa doesn't—and Navigator's partner in charge of the Illinois sequestration site, ARI, says on the front of their webpage that they are in the business of CO2 storage for the purpose of enhanced oil recovery. How "green" is that? Is ARI's oil recovery really a "public good" for Iowa? Or is it good for the ARI's profits and bottom line?

We live in the country by the Cedar River South of Mount Vernon in Linn County - living out in the country with no emergency responders within immediate range, will put our lives at risk in case of a rupture of the pipeline. We are writing to express our "opposition" to the proposed Heartland Greenway project. We are opposed because we feel this project is not safe for us as landowners, our neighbors, or our surrounding communities. We live next the Cedar River and have trees along the river that have provided habitat for birds and wildlife for hundreds of years. After the derecho we don't need a pipeline cutting down more trees to cross our property.

The Navigator CO2 Ventures, LLC is proposing to build a CO2 pipeline not just another petroleum pipeline. The thermodynamic properties of liquid C02 are not like that of liquid natural gas, and when a CO2 pipeline ruptures (which it will at some point) it can do horrific damage to humans, livestock, and property. As far as I know, our Iowa Legislature does not have specific rules in place for CO2 pipelines and thus, Navigator can determine where and how close it can go to lowan's homes and small towns. In Satartia, Mississippi there was a CO2 pipeline rupture in 2020 causing horrific scenes of people choking, losing consciousness, having seizures, and foaming at the mouth. This also had residual health effects on many of these citizens for life. Navigator says that this was due in part to contaminants: however, pure liquid CO2 is no safer. Pure liquid CO2 is an asphyxiant that can kill within 15 minutes. The proposed Navigator pipeline route in Iowa goes near many farmhouses and small towns that do not have emergency response teams capable of arriving at a rupture site before 15 minutes are over. At an informational meeting in Linn (December 6, 2021) and Cedar (December 7, 2021) Counties, Navigator's representatives refused to respond to the question of whether they would provide a self-contained breathing apparatus for every person on their proposed route.

Publicly-available scientific information from industry testing (aligned with the parameters of Navigator's own project) demonstrates a spread of over 1,300 feet in less than a 4-minute time frame (2021). A CO2 pipeline break

would risk death by asphyxiation for landowners, community members, livestock and plants living within a quarter of a mile or more of the pipeline. How can we be satisfied with the minimum 25-foot set back that Navigator's engineer described at the Linn County meeting? Our farm families and small towns (like Ely, Mount Vernon, Stanwood, Clarence, and Lowden in Linn and Cedar Counties) will be at risk—and even our school children (College Community School District)!

This project is not safe and has the very real potential to harm hundreds if not thousands of people across our beautiful state. Such risk is not a public good. It is time to prioritize the future of our communities and families above the private profits of out-of-state corporations. Please vote no to Navigator's permit application.

I would like to submit this letter of opposition for the Navigator Heartland Greenway pipeline in Linn County and the state of Iowa. I am a 5th generation farmer in Northeast Linn County. The proposed pipeline would not only cross my family's land, but cut our farm almost directly in two from the Buffalo River through our field valley, and our CRP conservation land. Our conservation land is a long-grass prairie preserve for many animals, including pollinators, quail, and pheasants, along with native prairie grasses and flowers. This land will be completely gutted by bulldozers and machinery if a pipeline is approved, destroying the preservation work that has been delicately maintained for decades. This is not an easily replaced ecosystem; marring the land and eliminating the habitat that conservation efforts have supported and promoted for decades does not seem like an 'environmentally friendly' or progressive investment by the state of lowa, especially since this pipeline supports continued dependence on fossil fuels rather than clean energy like solar and wind power.

For cropland, Navigator only guarantees full yield reimbursement for one year, then partial coverage for years two and three, with nothing after that point. The implications of such a large scale construction project without knowing the full long-term effects is not only a disservice to the land, but also to the residents of lowa who have invested their life's work into their property.

I find it interesting that although this pipeline has not yet received approval from the IUB, and potentially impacted citizens have yet to receive an 'official' map of where this pipeline will lie, residents of my county and others have already started receiving phone calls from Navigator representatives to survey and meet regarding property easement.

This situation requires an ethical and unbiased decision making board to acknowledge that the people of Iowa are the originators and owners of this land, rather than an out-of-state company who will not feel the repercussions of such a detrimental project. This pipeline is a paradox in environmental progression.

Dear Iowa Utilities Board

I am writing today to express my opposition to the Heartland Greenway proposed project. I am opposed because this project is not "green" and does not constitute a public good.

While Navigator states that the liquid CO2 carried in its pipeline will be permanently sequestered in Illinois, I believe that they are not telling the entire story. Sequestration is only the first part of a larger industrial cycle utilized by the oil and gas industry to extract more fossil fuels from fields that are otherwise depleted. Is Navigator building a pipeline that will transport CO2 only for the purpose of sequestration (thereby lowering carbon emissions), or are they preparing their project for other "industrial" uses (contributing even more carbon emissions in the long run)?

According to Navigator's own news release "Navigator Approved to Proceed with Development and Construction of Heartland Greenway System in Midwest" (2021), "Navigator is also in discussions with multiple parties that consume CO2 who would desire delivery interconnection points to provide a ratable, consistent source for CO2 acquisition." At the Linn County Informational Meeting on December 6, 2021, David Giles, Navigator's Chief Operating Officer, admitted that, "If the customer wants another use for CCS [beyond sequestration] we will consider that." While David Giles went on to imply that "industrial uses" for CO2 might include the food and beverage industry, we know that Navigator's own partners at the sequestration site in Illinois, Tenaska and ARI, describe themselves as leaders in fracking and enhanced oil recovery (EOR). Let's be clear: ARI does not make "pop," and I believe that it is disingenuous to suggest as much to all of us who gathered at the meeting that night. We are also aware that scientists at the Iowa Geological Survey (2021) have noted that the Mt Simon formations that will be used to sequester the CO2 in Illinois also run underneath land in Southwest Iowa-but in Iowa, these formations do not also promise oil. Iowa is not an oil-producing state. Isn't that why the pipeline is headed to Christian County, Illinois, an area ripe with depleted oil fields? Researchers have shown that major carbon dioxide capture and pipeline infrastructure projects based on CO2-EOR benefit the oil and gas industry and oil-producing states (2018). Illinois is an oil-producing state,

and a report by the Illinois State Geological Survey as early as 2007 admits that Illinois has been "seeking public-private partnership to develop a CO2 pipeline backbone to deliver CO2 from these projects to Illinois oil fields." One ton of liquid CO2 used in this way produces enough barrels of oil to add 1.2 tons of CO2 to the atmosphere (2018). According to peer-reviewed scientific research on the issue, the industrial cycle of CCS-EOR is net CO2 additive (2019).

In sum, Navigator's CO2 pipeline project is NOT "green" and is NOT a public good. I oppose the project because it will not benefit the people of our beautiful state. Please vote no to Navigator's application.

I would like to file an objection to the proposed pipeline.

First I feel the process has not been sufficiently open and transparent. I feel that the nature of this project and its associated hazards should require a much more robust and complete notification to property owners who may be affected. In this case only property owners where the pipeline is actually proposed to reside have been notified. In some cases property owners received late or no notification at all. Owners adjacent to the proposed easements have not been notified at all. Because the potential impact of an incident involving this pipeline could cover a wide area, I feel that any property owner within 1 mile of the propose route should be notified and invited to information sessions. In addition those who live in rental units along this route and those who work at businesses in this range should be notified in addition to those property owners.

Publicly available information about the project has been VERY difficult to find. That which is available is vague or incomplete to the point that it is misleading. Many news articles about this pipeline are behind paywalls or do not provide a link to the IUB where more information is available. Even on the IUB web site where there is a lot of information about this proposal, finding it is difficult.

Once I learned that the proposed route would take this pipeline along Springville Road (Linn County X20), I became more concerned. That road is the only possible route for my family to evacuate any emergency situation that might arise. After seeing the result of a similar pipeline exploding in MS last year I feel this concern is warranted. Any such event along that route could cutoff the only route of escape for all the residence along this road and any similar roads along the route.

I feel that the proposed pipeline is not a public need and will provide no benefit to anyone in Iowa except the customers of the pipeline. I feel the environment benefits of this pipeline are vastly overstated and that they will have a much shorter lifespan than the pipeline itself. If this pipeline is constructed and subsequently becomes unprofitable, it is likely that it could be repurposed to other, even less desirable operations from an environmental and safety standpoint.

For all these reasons and others already express by other property owners, I am opposed to this project. I ask the Iowa Utilities Board to reject this

There will be compaction and tiling issues that will likely last the remainder of my lifetime, not to mention loss of trees, CRP acres and other habitat on ground that is not currently farmed. The living soil that Mother Nature took thousands of years to create, Navigator will undo in months. And all of this will be for what? For money stuffed into the pockets of Navigator and their investors?

It is time to prioritize the future of our land, our communities, and our families above the private interests of out-of-state corporations. Navigator's project is <u>not</u> a public good for Iowa, and I am opposed to their CO_2 pipeline.

In early November I had been notified by certified mail from the company that my land was in the path of its proposed CO2 pipeline and that the public informational meeting in my county is set for Wednesday, December 15, 2021 at Ellsworth Community College in Iowa Falls. According to that letter, Navigator cannot legally negotiate with affected landowners in any one Iowa County prior to the conclusion of the public informational meeting in that county.

We are also aware that scientists at the Iowa Geological Survey (2021) have noted that the Mt Simon formations that will be used to sequester the CO2 in Illinois also run underneath land in Southwest Iowa-but in Iowa, these formations do not also promise oil. Iowa is not an oil-producing state. Isn't that why the pipeline is headed to Christian County, Illinois, an area ripe with depleted





Hello. My name is Susan Deibner. I am a landowner on a property that could be transgressed should this proposal be approved. One might wonder if I have used the correct verb here, transgress, but it does apply to this situation as I believe this infringes on our rights as citizens of this state, nation, and earth. It also goes beyond the bounds of human moral principles, especially within our country, and is just plain disrespectful bad behavior. I do not and will not accept any offer to allow such a pipeline to cross my land and will fight against any effort to cross the land of any of our neighbors. We purchased this small farm 7 years ago and are carefully and meticulously improving the land, the woods, and especially the organic apple orchard. We just began a project with Melody Rockwell, the adjacent landowner, to initiate a prairie through a government program. We have landscaped and prepared our lane to be used as parking for my husband's pottery and art sales. We are at the point where we can begin to offer our organic apples and juice for commercial sale at farmer's markets and CSA sales.

Our property has one small creek that crosses our wetland area and our lane such that every year since we have lived here, our creek that crosses our lane in front of our house moves from a 4-foot-wide creek to a 100-foot-wide waterway with depths such that we cannot leave or enter our property. This has happened multiple times in a season, but it doesn't last that long usually. However, referencing what the Navigator engineer said in the public forum on Monday evening, December 6, 2021, extreme rainfall was responsible for the rupture of the pipeline in Mississippi. We too have extreme rainfall occurrences, and they are becoming more common as recent history shows, another example being two derechos in two years with both wind and rainfall. These moments of inconvenience to us have become an exciting example of just exactly how we as humans can never fully be in charge. Nature always has a card up its sleeve, so we must work with the land. Our good friend and neighbor, Melody Rockwell owns the property on both sides of Elbow Creek along Springville Road. Elbow Creek floods every year and has in recent years been enough to cause a reduction in the agricultural production in those fields. In most years, the production is still decent because of good land management practices.

In the past few decades, we have begun to have extreme weather incidents,

including floods in 1991, 1993, 2002, 2008 and regional in years in the teens. That goes without mentioning that we have had two Derecho windstorms with torrential rainfall in two years, and Derechos were unheard of in Iowa before the summer of 2020.

The Linn County Flood Factor online site indicates the following warning for its citizens:

"Flood risks are increasing because of the environment.

A changing environment means higher seas, new weather patterns, and stronger storms. As the atmosphere warms, there is more evaporation and more water available when it rains. A warmer atmosphere also means warmer oceans, which can intensify flooding from hurricanes and offshore storms." This is evidence that the Navigator engineer's offhand comment that "the

Mississippi disaster was caused by a lot of rain and mudslides, and that won't happen here" is not a valid argument to dismiss the great threat the pipeline would mean for the citizens of Iowa.

Navigator wants the pipeline in order to make corporate profits for the CEOs and employees of Navigator and their parent company, Valero. That is understandable. People who have companies want them to be successful, profitable. However, Navigator wishes to do this at the expense of private land that is being appropriately used for agriculture by the landowners or persons renting that land. When Navigator tried to convince readers in their literature and attendees at the public meeting that they were doing a "green project" that would be beneficial to the general public, they stated that they were intending to sequester the CO2 in the depths of a particular geological landform in Illinois where it was to be "left forever." But in a response to a question a few minutes later they said, "we will not rule out selling the CO2 for profit in the future." They also said the reason the CO2 had to be piped to Illinois was that similar geological land structures did not exist in Iowa. That is a straight out lie. Anyone who can use their intelligence to seek out and read scientific

articles about the geology of Iowa can find that information. We know about the connections between Navigator and the oil companies who have great interest in using CO2 to extract oil from old oil wells, and that it can be used in fracking. "Using CO2 eliminates the need for a massive water supply—reducing the pressure on water resources such as reservoirs and opening arid locations for fracking. It also creates underground storage capacity for captured CO2."

There is a new technology that has been researched and is available for development in which CO2 can be converted to liquid fuel – namely ethanol – using a nano catalyst and a very available green energy source, specifically solar panels. This is great news in many ways, and it does mean that companies, especially oil and other energy companies, are going to want to negotiate mutually beneficial enterprises to capture the CO2 and convert it to ethanol to be sold for many uses. It is obvious that Navigator wants to beat the rush by sequestering the CO2 for themselves. They will then be able to negotiate to sell the CO2 or build the ethanol producing plants through deals with their brother companies.

Any way you look at the pipeline proposals, it is obvious that they are for corporate gain, not for the greater good of us lowans. I am shocked that anyone in our government would have let these companies get even this far in their proposals. Why should we lowans have to invest this amount of time, and likely a great amount of money in defending our own productive land against a group who could not even answer the simplest questions at the public meeting in Cedar Rapids Veterans Auditorium. I could not count on two hands the number of times the speakers would say "We don't have that determined yet," "that is what we are still working on," "that is something that will be determined once we have the go ahead," etc. These are not exact quotes, but we heard this rhetoric over and over ad nauseum. I will end this comment here, but there will be more. I object to this proposal and will do everything in my power to stop it along with my lowa friends and neighbors who love the land.

We strongly object to the Hazardous Liquid Pipeline (CO2) proposed by Navigator CO2 Ventures, LLC.

The Stein Farm, a "Century Farm," is a small family farm by Iowa standards. It has been been owned by the Stein family for more than 120 years. In the last 5 years,

Ted W. Stein, Trustee of the Ted W. Stein Trust (hereafter "Stein Century Farm"), has been approached 4 times by private entities seeking to run utilities across the Stein Century Farm. These numerous petitions amount to a de facto nuisance. The last time was only a few months ago (in October, 2021) - the NuStar High Pressure Ammonia Line. Each entity has sought access to the Stein Century Farm in a classic taking. Without apology or compunction, each entity has threatened to use the power of the state (eminent domain) if we refuse the toxic pipeline. As a Century Farm, the Stein Century Farm should be exempt from an eminent domain taking.* Iowa Code Chapter 479B (hereafter "Statute") was never meant as a bludgeon to erase Farmers' rights, but it has become so. In the last public meeting on December 8, 2021, the representative from the Iowa Utilities Board (IUB) indicated there are FIVE (5) pipeline petitions pending before the Board. This is a never-ending story and it is unacceptable. The present interpretation of the faulty Statute is causing cumulative harm to lowa's farmers.** The Statute is overly-broad and is being interpreted by the pipeline companies as an open invitation for a free ride in Iowa, so "come on down." Further, the Statute is subject to challenge as an inappropriate use of the police power. There can be no valid police power purpose which takes farmland to benefit a private company. There is no "public good" deriving from this CO2 pipeline.

Navigator CO2 Ventures, LLC must be required to justify any taking based on predictable adverse events.*** The high pressure CO2 pipeline is based on shaky science, and is almost all funded by tax credits and subsidies. It is a matter of political fiat. This means that Iowa farmers will ultimately pay

for the pipeline in three ways: first, farmers share in paying state and federal taxes to subsidize the pipelines; farmers lose valuable revenue from farmland that is never fully restored to its prior productivity; and the input costs for farmers radically increase. In other words, the various pipelines maximum their profits by shifting what they are stealing from lowa farmers to other markets. An example of this is the privately-owned fertilizer plant in Wever, Iowa (3 miles from the Stein Century Farm) which was built with subsidized tax dollars. The backers of the fertilizer plant loudly proclaimed that the fertilizer plant would benefit the LOCAL Farmers. Well, guess what? The Stein Century Farm paid approximately \$800 the last time fertilizer was applied to the Stein Century Farm (about half of the acreage); two weeks ago, we received a bill for \$6,000 for the same fertilizer, and the price per ton of fertilizer continues to rise. What is the real benefit to Iowa farmers? Nothing. This is a HAZARDOUS pipeline carrying TOXIC materials under HIGH PRESSURE. It could endanger the whole community. There is no conceivable benefit to lowa farmers; the argument that the pipelines benefit Iowa Farmers is an outright and blatant lie.

The pipeline will cause substantive harm to the Stein Century Farm. In addition, the environmental impact of a CO2 pipeline is high. The pipeline company seeks to damage or destroy all or part of our Walnut Grove. This is an actual physical invasion of our property serving no public purpose. We estimate that some of our trees are more than 80 years old. Priceless and irreplaceable. We had planned to build a house there. We paid \$27,000 to Lou Heiser, a well-known architect, to develop plans for our new home. We hoped that our children would eventually build near the Walnut Grove as well.

The old brick house had been sited right in front of the Walnut Grove, and our plans are to put a fruit tree orchard there in commemoration of our family's history in the region (since October 31, 1901). In addition, we have dedicated 3 small fields (4.01 acres total) near the Walnut Grove to pollinators. This is CRP property. The pipeline would wipe out our pollinator fields and our Walnut Grove. It should be recognized, also, that the Stein Century Farm, right now, without any pipelines crossing it, is a healthy investor in the well-being of the planet. We have many trees in the Walnut Grove, the south side wood lot, and around the log house as well. Our farming practices and the land we have set aside for animals and the environment sequester CO2 in a natural way. We operate the Stein Century Farm in a way that is very cognizant of our environmental impact. The pipeline will also destroy access to our machine shed (The Cricket Barn), which we are in the process of renovating. We just added a new cement floor (more than \$13,000) and rolling doors (approximately \$1,000 each), with plans to put in solar to re-electrify it. The minimal amounts offered by the pipeline company as "compensation" will never fully cover our sweat, tears, plans, and hopes for our Stein Century Farm. We do not want ANY pipeline on our property, The pipeline company has many, many other options. Navigator is using market mechanisms to enrich itself at our expense.

The neighbor to our south is a hard-working farmer with a young family, and he has accepted the ammonia pipeline. There is no reason that the CO2 pipeline cannot be re-routed to a location alongside the ammonia pipeline. The main reason the pipeline wants to take our land is because it is a straight-shot to the privately owned fertilizer company - to minimize the expense to the fertilizer company and its investors, of course. As stated above, this hazardous, toxic, high pressure pipeline will not benefit the Stein Century Farm in any way. The burden of forcing an unwanted pipeline should be on the entity seeking state approval for it, not on the farmer who is a true husband of the land. The Statute requires a strong, affirmative defense by any farmer who wants to protect his right to say "NO" to a pipeline. This is an unfair shifting of the burden. A farmer should not have to do anything to assert his right to keep and use his own property. Many farmers do not have the time or resources to respond to a well-funded assault on his ownership rights. If a farmer is unable to act for some reason, the private pipeline entity will just roll right over the farmer and his rights.

At the public meeting on December 8, 2021, unfortunately not made a part of the record, many farmers spoke out about the ill effects of prior pipelines on their property; they talked about the subsidence of the land, the hostile attitude of the company representatives, and the poor production of previously high-yielding parts of their farms. They also spoke of their efforts to seek damages, even help from the IUB, with no luck. The IUB representative seemed oblivious and unsympathetic to the farmers' plight. The IUB, of course, sees its actions as simply following the law, "just doing their job," even if it means disadvantaging farmers in lawless efforts to assist in the land grab. All they have to do is "check the boxes" to make everything OK (as far as they are concerned.) They don't see themselves as having any duty whatsoever to follow up on the farmers' situations. At the very least, the IUB should initiate a remedial investigation of the cumulative effects of numerous pipelines crossing farmland in Iowa. This step is obvious to assure that human health and the environment in Iowa are not being adversely affected by the current rush of pipeline companies to have lowa service private entities. It would be a better use of Iowa taxpayer's money for the IUB to initiate an investigation into the impact on farmers' property rights than for the IUB to facilitate more pipelines crossing our state. To my knowledge, no investigation has been made to date concerning the adverse issues affecting lowa farmers.

Farmers are being held hostage in lowa by hostile pipeline companies who now are asserting the absolute right to cross our farms, because of the faulty statute enacted in 2016. There is no doubt that the lowa Legislature did not intend the Statute to wipe out the farmers' property rights in lowa. I believe the Legislature was bamboozled by the wealth of the privately owned entities and their investors, such as Blackrock and Vargus, who appear to have a hidden agenda. (They would not disclose any financial data at the public meeting.) Navigator representatives argued that the company's "global" interests justify the pipeline and failed to disclose what financial benefit the company itself may receive from future use of the CO2 stored in Illinois. With some research, I would not be surprised to find out that the underground storage facility (in Illinois) is close to pockets of natural gas which could be fracked by using the high-pressure CO2 flowing across lowa and being delivered to Illinois. Not one farmer will benefit from the future use, whatever it is, of the CO2 running through the pipeline.

You can be sure that the Iowa farmers will not receive one cent of the profits going to these private entities. We do not believe in socialism. Isn't it because the "industrial use" that navigator's COO, David Giles, mentioned at the Linn County public meeting on December 6th is actually enhanced recovery of fossil fuels? Illinois has fossil fuels—Iowa doesn't—and Navigator's partner in charge of the Illinois sequestration site, ARI, says on the front of their webpage that they are in the business of CO2 storage for the purpose of enhanced oil recovery. How "green" is that? Is ARI's oil recovery really a "public good" for Iowa?

Our farm families, living out in the country with no emergency responders within immediate range, will have their lives put at risk in case of a rupture of the pipeline. Revitalization and growth efforts made by our small towns (like Ely, Mount Vernon, Stanwood, Clarence, and Lowden in Linn and Cedar Counties) will be snuffed out by a new pipeline that skirts the city limits. Navigator's pipeline will also rip through hundreds of acres of prime lowa farm ground, destroying the soil structure that gives us our exceptional growing capacity. Our farm families have cared for the land for generations, but now my neighbors and I will see our CSR numbers lowered because of Navigator's project. There will be compaction and tiling issues that will likely last the remainder of my lifetime, not to mention loss of

trees, CRP acres and other habitat on ground that is not currently farmed. The living soil that Mother Nature took thousands of years to create, Navigator will undo in months. And all of this will be for what? For money stuffed into the pockets of Navigator and their investors? Let's be clear: what Navigator CO2 Ventures, LLC is proposing to build is not just another petroleum pipeline. The thermodynamic properties of liquid CO2 are unlike that of liquid natural gas, and CO2 pipeline ruptures come with extraordinary risks. Navigator says that the horrific scenes-choking, loss of consciousness, seizures, foaming at the mouth-at the site of a liquid CO2 pipeline rupture in Satartia, Mississippi (2020) were due in part to contaminants; however, pure liquid CO2 is no safer. Pure liquid CO2 is an asphyxiant that can kill within 15 minutes. The proposed Navigator pipeline route in Iowa goes near many farmhouses and small communities that do not have emergency response teams capable of arriving at a rupture site before 15 minutes are over. At the informational meeting in Linn county, when asked, Navigator's representatives refused to respond to the question of whether they would provide a self-contained breathing apparatus for every person on the route. Also at the meeting in Cedar Rapids for Linn County, Navigator's engineer, Stephen Lee, stated that he did not know how far or how quickly the deadly CO2 cloud would spread in the event of a rupture. However, this is publicly-available scientific information. Industry testing (aligned with the parameters of Navigator's own project) demonstrates a spread of over 1,300 feet in less than a 4-minute time frame (2021). A CO2 pipeline break would risk death by asphyxiation for landowners, community members, livestock and plants living within a quarter of a mile or more of the pipeline. How can we be satisfied with the minimum 25-foot set back that Navigator's engineer described at the Linn County meeting? Our farm families and small towns (like Ely, Mount Vernon, Stanwood, Clarence, and Lowden in Linn and Cedar Counties) will be at risk-and even our school children (College Community School District, Mount Vernon Community School District)

It is time to prioritize the future of our land, our communities, and our families above the private interests of out-of-state corporations. Navigator's CO2 pipeline project is not "green", not safe, not in the best interest of our local farmers and is not a public good. The project is not for the public good of Iowa and I am strongly opposed to their CO2 pipeline.


