We would like to let you that we are opposed to the dockets highlighted that are being proposed to pass through land that we own. We are 4th generation owner/operators of this ground and are also opposed to eminent domain in the acquisition of said property.

There are too many questions and dangers of having the pipeline, one of them it being only 4' below the ground. If this is the case, the temperature will be so high that it will not be feasible for crops to grow. The ground will be dead. Also, if there would be a leak in the pipeline and the CO2 escapes, anything nearby would immediately suffocate. We have livestock that is allowed to graze the harvested fields in the fall, and what a tragedy it would be to lose a cow/calf herd that is 30-35% of our yearly income due to a situation like that! And if anyone would be doing fieldwork or repairing fence, well, you see where I'm going.

Also, if they do take our ground, it won't be in a straight line along the edge of a field, it will go diagonally across of it. How will we farm the field? Will there be a separate driveway for each section of a parcel? Will there be an easement?

This is just one more way to take more land out of production, and raise the possibility of industrial destruction, with possible loss of lives.

We are against it and hope you will hear us and vote against any part of it. Thank you,

Mr. Vilsack is involved in making federal policy for companies such as Summit Carbon Solutions pertaining to rules and regulations of CO2 sequestration and pipeline installations across this great State of Iowa. How convienient for SCS to hire him. Can you imagine a Sunday family get together in which Mr. Tom Vilsack and his son are together and a potential conversation they might have at that time??? It might start out with, "How's your new job, son?" Jess replies, "It is going great dad. The people I work with have really been very welcoming to me and are easy to work with. These are the 5 rights which a land owner has when inheriting or buying land. 1. The Right of Possession, which refers to ownership. "A property is owned or possessed, by whoever holds the title to it." 2. The Right of Control. "The right of control is also described as the right to manage-in Honores words, the right "to decide how and by whom a thing shall be used." 3. The Right of Exclusion. Other people can be excluded from tresspassing onto your property or entering your home, and this right is very well protected." There are exceptions and these include law enforcement officers with a warrant or a UTILITY COMPANY that is requesting an easement in order to maintain rights of

The Right to Derive Income. Owners can generate income from their property by renting it out to a person or a business that the owner selects. 5. The Right of Disposition. "Disposition means that the property holder can transfer ownership to someone else, including after their death in a will. The owner can sell it or give it away if they so choose." In conclusion we can say that the idea of property ownership is a collection of rights in relation to other people is the dominant way of looking at property rights under the UNITED STATES LEGAL SYSTEM. Please maintain these land owner rights for us by not granting a permit to SCS or Eminant Domain.
#3. Mr. Emil Henry, Jr is the CEO of Tiger Infrastructure providing investor

monies to Summit Carbon Solutions for the funding of the proposed CO2 pipeline across our property. My name is Jason Howard. I am a landowner in Palo Alto County, currently residing in Arizona, affected by the Summit Carbon Solution CO2 pipeline. The affected property is located at 4935 440th Street, Mallard, IA. This farm has been in the Howard family since 1940. My grandfather purchased the initial portion, and over time my father added additional land, growing the farm to over 900 acres.

I OBJECT to the placement of this pipeline across my land. I want to state at the outset of this objection that I have no intention of voluntarily granting an easement across my land. My specific objections are as follows.
1. At present this land is under a CRP contract with the FSA. This represents are large portion of my family's income. Should construction begin on the affected property, the status of that CRP contract is uncertain.

Ultimately, this pipeline is negatively impacting the livelihoods of those farmers and other landowners on the pipeline route.

2. Our intent is to return the land to cultivation in the future. Trenching for the pipeline will undoubtedly damage tiles installed in the affected areas, making this a much more difficult and costly proposition.

3. Condemnation of the land for the pipeline easement through imminent domain, should it come to that, will not be done in the public interest. Instead, IUB would be using imminent domain to force an easement across private property for a private interest. What's more, this easement will allow Summit Carbon Solutions staff and contractors to access the property at any time. This is not a condition I would willingly accept, but the presence of this easement will allow for this to happen.

January 10, 2022

Neither public money for pipeline construction, federal tax credits nor eminent domain should be used to support the proposed Summit Carbon Solutions compressed CO₂ pipeline across Iowa. Navigator CO₂ Ventures would store the gas underground at an existing ADM ethanol facility and pilot carbon capture & sequestration site near Decatur, IL; Summit Carbon Solutions would store gas underground in ND, where it could be sold for use in fracking additional petroleum.

CO₂ emissions from the continuous fermentation process at each ethanol refinery would need to be captured to join the pipelines. Some progressive ethanol refineries are already capturing and bottling their CO₂ and selling it for carbonation of drinks, dry ice production and other uses. If the CO₂ is permanently sequestered the carbon "footprint" of their ethanol process is reduced, improving the "Green" score of their ethanol for selling into the CA market. Proposed federal tax credits of \$50+ per ton of sequestered carbon could also be claimed by individual refineries, improving the return on investment.

The entire Ethanol production process produces fewer GHG emissions than petroleum fuels, but exhaust emissions are a major contributor to climate change. 50% of the corn produced in Iowa is currently sold to ethanol refineries. As the US and world move to increasing the percentage of renewable electricity as well as hybrid and electric vehicles, Iowa corn growers need to consider other markets than ethanol, as well as alternative crops that will be better for our soil and water quality.

lowa citizens are increasingly requesting and adopting renewable electricity and reducing reliance on all fossil fuels. Capturing and sequestering CO₂ emissions from ethanol plants would be a good thing, but we don't need and don't support ANY more pipelines across our state. Individual ethanol plants motivated to do so can capture and bottle their CO₂ emissions; or sequester them underground, but should not receive any public funding nor be enabled to use eminent domain to do so.

My wife Lucy and I, and my sister Alessandra, are writing in opposition to the proposed Summit Carbon Solutions plan to pressurize carbon dioxide emissions from ethanol plants and pipe them across the state of Iowa. Their proposed pipelines would run across our farm. This farm has been in our family for roughly 135 years. Members of the family have always been good stewards of this land, and we don't plan to change that now.

It sounds like the goal of the Summit Carbon Solutions plan is toreduce net carbon emissions from ethanol plants. While this is an admirable goal, I believe the proposed plan is far more inefficient than it should be, and causes unnecessary harm to one of this country's most valuable resources, its farm land. In addition, it could possibly present hidden dangers to nearby residents. It severely violates an owner's rights to control what happens on their property due to eminent domain potentially being used to run the pipeline. This project is an affront to our rights as Americans.

From the information provided so far, it looks like ethanol plants in lowa are either having trouble, or are expected to have trouble, selling ethanol into markets like California. California is a huge market, indeed, and it's tempting to jump through their hoops to be able to sell lowa's product there. California has many environmental regulations in place that are intended to encourage "green" products and discourage non-green ones.

The assumption is that it's difficult for companies in California to buy lowa ethanol due to these regulations, because of the fact that significant greenhouse gases are generated in the production of ethanol. The proposed Summit Carbon solution is to recover some of these generated greenhouse gases and store them somewhere where they can't get into the atmosphere and cause climate change. The proposed solution recovers some of these gases, transports them several hundred miles through an extensive pipeline system, then attempts to "bury" them in bedrock in North Dakota, if my understanding of their process is correct.

This solution has many drawbacks. First of all, in order to do this, hundreds of miles of pipeline have to be run through some of America's most valuable farmland. This requires extensive time and energy to implement, with its associated release of additional greenhouse gases, anyway. construction equipment is needed to dig up the fields and lay the pipe. How much energy, greenhouse gas, and man-hours are expended in all this? How much time will this require? If it takes three years to get this going, how much carbon dioxide could have been neutralized during this time if a better, more expedient plan had been chosen beforehand instead? What happens if there is a leak in the piping system once it is done? Summit Carbon assures us they are modeling this situation, to attempt to predict the dangers involved. Shouldn't this have been determined before even starting the project? Will the project go on if it is discovered anyone within 500 feet of such a leak is susceptible to asphixiation, similar to what happens in carbon monoxide poisoning? Are there other possible dangers due to the gas escaping a high pressure environment? Isn't this very presumptuous to consider running this throughout the heartland? Surely there must be a better way. What happens if the company disappears after several years, which could very well happen, based on the track record of other recent "green" projects? The company will have banked their profits, but the farmers will be left with a useless pipeline system in perpetuity!

If the goal is reduction of carbon dioxide, why does it have to be carbon dioxide directly from the ethanol plant in question? Carbon dioxide in the atmosphere is carbon dioxide, regardless of where it is generated, whether it be from a standard industrial manufacturing plant, power plant, or ethanol plant. The climate doesn't care if the neutralized carbon dioxide originated in Iowa, Minnesota, North Dakota, or even Australia. Why do we need to recover the exact carbon dioxide generated in the ethanol plants? Couldn't we find some power plant or manufacturing plant in North Dakota or northern Minnesota, that is much closer to the destination where the carbon dioxide will be stored underground? Why not recover carbon dioxide there and pump it a much shorter distance? This would save lots of time and energy. There would be far less wear and tear on the state of lowa, its farmland, and its people. It seems like a type of credit system could be utilized whereby the ethanol plants in lowa pay the plants closer to the destination in order to recover and store their carbon dioxide. How about using something like the current carbon credit system? With the highly complex carbon credit system we already have today, surely there must be a way to arrange this. If the regulations in Iowa or California or wherever disallow this, then I'd say the system is broken, and the system needs fixing, not lowa's farmland and ethanol plants.

In short, I believe that finding a place to recover the carbonemissions much closer to the storage destination is a far more efficient and effective solution. It would save lots of time, greenhouse gases spent in the process of running the pipelines, man-hours in implementing this very elaborate system, and save untold wear and tear on a highly valuable natural resource, the nation's farmland. If there is no way to do this in the present system of carbon credits, I'd say that is a massive failure in the carbon credit system, and this system is broken and needs to be fixed. Are we so mired in senseless regulation that we cannot find a way to create a system as I've proposed, where carbon dioxide is neutralized far closer to a source, and paid for by the ethanol plants, to make their product more available to other markets? Climate doesn't care where the reduction occurs. If this isn't possible, I'd say this is a complete failure of our environmental regulation system, and we need to start over. If it is possible, then why are we still going down the road implementing this overly complicated plan that is doomed to fail, as soon as someone comes up with a more efficient method? What if the project only survives five years, and the company disappears after that? The company will have mined its profits from the farmland, and the farmers will have to live with the bad effects of the useless pipeline forever after. Please reconsider implementing this project.
