RE: Verification of Study Area Boundary Information

The Utilities Board (IUB) annually certifies incumbent local exchange carrier (ILEC) study area boundary (SAB) data with the Federal Communications Commission. This service, performed by the IUB, is on behalf of Iowa ILECs with the exception of Windstream and Qwest/Centurylink (n/k/a Lumen). Certification is a FCC requirement and is due annually by March 15.

In order to ensure the IUB provides and certifies accurate SAB information with the FCC, the IUB is requiring that each ILEC verify its SAB information by filing verification of its SAB information in the IUB's electronic filing system no later than January 31, 2022. The filing should be titled "Verification of Study Area Boundary" and must include the ILEC Company Name and Study Area Code. A list of company names and corresponding M dockets is attached to this letter for reference.
