DESIGNATION OF COUNTY INSPECTOR

Comes now the Hancock County Board of Supervisors naming and designating the firm of **Snyder and Associates, Inc.** (hereinafter referred to as Hancock County Inspector), a professional engineering firm with engineers licensed under Iowa Code Chapter 542B, to serve as Hancock County Inspector in the construction of the Summit Carbon Solutions Pipeline System. Hancock County Inspector shall be responsible for, but not limited to, on-site inspections and documentation of compliance with the IUB's standards for restoration of agricultural lands in accordance with the restoration plan, and/or the written independent company and landowner agreements.

Pursuant to 199 IAC 9.1(2) and Iowa Code SS 479.29 and 479B.20, proper notice shall be provided by pipeline company or pipeline company's contractor or representative of all onsite activity including, but not limited to, surveying, staking, clearing, topsoil stripping and stockpiling, trenching, lowering-in, tile repairs, backfill and compaction, hydrostatic testing, boring, restoration, or any other pipeline construction activity or pipeline pre-construction activity in Hancock County, Iowa, to the following point of contact:

In addition, the pipeline company or the pipeline company's contractor or representative shall provide the Hancock County Inspector the following records: construction schedules, alignment sheets with tract information, project route, and right-of-way limits, project specifications, procedural manuals, list of affected persons, independent landowner agreements, topsoil survey depth results, any tile maps received from landowners, and any other document pertinent to the construction of the pipeline in Hancock County, Iowa.

In addition, payment for services of Hancock County Inspector, regardless of whether the pipeline is constructed, shall be borne by the pipeline company with Hancock County submitting monthly invoices and monthly payments made by the pipeline company.
