Ladies and Gentlemen:

This is my formal objection to the carbon pipelines proposed by Summit, Navigator and ADM. Please deny permit applications to these companies. My name is Pamela J. Lines, Trustee of the Lines Trust and I'm an impacted landowner in Floyd County of a proposed CO2 pipeline. Summit Carbon Solutions, LLC has violated Iowa Law, 479b.14, because it did not send the required 10-day notice prior to survey via restricted certified mail. The letter intended for me was sent via certified mail only, which is not the same as Restricted Certified Mail.

This is another example of this company not following lowa law. Proper notice via Restricted Certified Mail is important to ensure the landowner knows that someone will be on their property. Proper notice ensures safety and transparency. The USPS defines Restricted Deliver as "allows the mailer to direct delivery only to the addressee or the addressee's authorized agent".

Perhaps this is an attempt to save the \$6.00 in additional cost that a proper Certified Mail Restricted Delivery costs above the \$3.75 for a Certified Mailing. If this is the intent, it should not give the IUB confidence in the financial stability of this company.

lowa law is clear, and it is unacceptable that this pipeline company would skirt the law. If they can't even follow simple lowa laws around notification, how can I trust that they will follow any other law meant to protect lowans?

Iowa Law 479B.21 provides "A person who violates this chapter or any rule or order issued pursuant to this chapter shall be subject to a civil penalty levied by the board in an amount not to exceed one thousand dollars for each violation". I formally request that Summit Carbon Solutions, LLC be issued a civil penalty of \$1,000 for this violation. This has caused myself and my family a significant amount of stress and inconvenience in worry and wasted time, as well as legal fees to understand our rights. You simply can't allow us to be treated this way.

I am a widowed 69-year-old retired School Librarian who was told by the representatives of DDSI of Tulsa, Oklahoma that they had permission to be on

my land to survey. When I asked who gave them permission, they said their boss did. I told them I had not received notification of survey intentions and I considered them trespassing. The foreman of the crew argued with me that they were going to survey. He insisted that I did not know what I was talking about. As an older female I felt extremely intimidated and dismissed by the male survey crew. If my son had not been there, I feel I would have been sidestepped. I contacted the Sheriff's Department of Floyd County, who sent out a Deputy to get these people off my land. My late husband and I worked hard all our life to purchase our farm and to have my rights as a landowner thrown in my face, I feel is a violation of my rights!

Attached is a copy of the Sheriff's department report of this trespassing violation that occurred on March 28, 2022.

I also formally request that any information obtained via such illegal surveys that were conducted without proper notice not be considered by the IUB at any further date and that they are deemed invalid.
