RE: Proposed CO2 Pipeline Project

Please accept this letter as a formal objection by the Lee County Board of Supervisors, to the construction of a carbon dioxide pipeline as proposed by Navigator Heartland Greenway LLC.

The Board has listened to its private citizens and landowners and we agree that the construction of the pipeline not only disrupts the agricultural economy of Lee County, but we are concerned with the safety of our citizens in the event some unfortunate incident should occur.

We respectfully request that the Iowa Utilities Board consider the principles set forth in Iowa Code 6A.21. Portions of this code clearly demonstrate the protection of agricultural lands from private development. Unlike natural gas pipelines or fuel pipelines, CO2 pipelines serve no public purpose. The precedent set by granting of eminent domain to projects like this, would mean that eminent domain could be used for any number of projects for which it was never intended.

Lee County strongly urges the Iowa Utilities Board to cautiously and carefully consider the nature of the benefits when determining public convenience and necessity of the proposed pipeline.

This Board, as the undersigned, having been elected to represent the Lee County residents and taxpayers, do hereby support them in their opposition to the CO2 pipeline and ask the Iowa Utilities Board to deny any and all permits and/or eminent domain declarations against the landowners in Lee County.
