Dear Iowa Utilities Board Members,

I contacted Representative Megan Jones, and she recommended I contact you.

I own land in both Sioux County and Clay County in Iowa. I grew up in Thompson, Iowa; graduated from Iowa State University in 1984; met my husband - a graduate of Boyden-Hull - Jim Ver Meer at college; married and moved to rural Sheldon and the John R. Ver Meer Farm Corporation - Jim's family's farm. We farmed and raised our 4 children there for 13 years before we moved to Colorado Springs and now to Alabama. Jim is still shareholder in his family farm, and I bought my Wiemers Family Farm in Clay County (Summit Township) when my father died several years ago. Both of our farms have been in our families for over 100 years. We have pride in our heritage, knowing the stories of our grandparents struggling to keep the farms through the Great Depression and the Wars. We lived through both of our fathers sacrificing much to pay the ridiculously high interest rates to finance farm mortgages in the 1980s and the farm crises. We have raised our own children with their delightful memories on these pieces of land.

Two days ago, I received this text message from phone number 408-220-5114, someone I don't know nor do I know if he's actually who he says he is:

"Hello my name is Steven Doran, I'm an acquisition agent with Universal and I would like to talk to you about purchasing an easement From you for the Navigator

CO2 pipeline in Iowa. I would appreciate a call back at your earliest convenience so I can pass along the information I currently have regarding the project."

Me: No.

"Would it just be OK if I send you a package with the information in it."

Me: Ok.

First of all, I typed this message as the sender typed it with the punctuation and grammar errors. It is insulting that whoever this is can't even communicate in proper English, which makes me suspicious. Secondly, is this a business practice that is supposed to build trust? Because this looks like spam.

The cunning BlackRock organization and all of the deceptive Green New Deal money and power grabbers have decided that they can take this land, destroy it by digging it up, then poison it and we as farmers are to sit quietly by, while they make their billions.
