ORDER REGARDING JULY 1, 2014, FCC ELIGIBLE TELECOMMUNICATIONS CARRIER ANNUAL REPORT FILINGS

(Issued June 11, 2014)

In reforming the federal Universal Service Fund (USF) and intercarrier compensation system,¹ the Federal Communications Commission (FCC) adopted new rules governing annual reporting requirements for eligible telecommunications carriers (ETCs). New rules at 47 C.F.R. § 54.313 relate to the annual reporting requirements for ETCs receiving high-cost USF support. Annual reporting requirements for ETCs receiving low-income support are established in 47 C.F.R. § 54.422(a). Reporting requirements for ETCs receiving Mobility Fund Phase 1 support are addressed in 47 C.F.R. § 54.1009.

§ 54.313 with the FCC, the Universal Service Administrative Company (USAC), and relevant state commissions using FCC Form 481 by July 1, 2014. ETCs receiving low-income support must file the information required by § 54.422(a) with the FCC, USAC, and relevant state commissions using FCC Form 481 by July 1, 2014. Pursuant to 47 C.F.R. 54.1009, a winning bidder authorized to receive Mobility Fund Phase 1 support must submit an annual report by July 1 in each year for the five years after it was so authorized; such reports must be filed with the FCC, USAC, and relevant state commissions using FCC Form 690 by July 1, 2014.

To ensure timely and efficient filing of these reports, the Utilities Board (Board) is issuing this informational order with the following instructions about when and how to file the reports. (Instructions for other ETC filings due July 1, 2014, were included in the Board's April 9, 2014, "Order Requiring Filing," in Docket No. IAC-2014-3906.)

1. Filing Date

FCC Form 481 (High-cost support, low-income support)

FCC Form 481 must be filed with the FCC, USAC, and the Board no later than July 1, 2014. The Board encourages ETCs to make their filings with the Board as soon as possible in advance of July 1, 2014. All reports filed in the Board's electronic filing system (EFS) prior to 3:30 PM on July 1, 2014, will receive a July 1, 2014, date stamp. Pursuant to 199 IAC 14.9, filings that arrive after 3:30 PM may not receive a July 1, 2014, date stamp.

FCC Form 690 (Mobility Fund Phase 1 support)

FCC Form 690 must be filed with the FCC, USAC, and the Board no later than July 1, 2014. The Board encourages ETCs to make their filings with the Board as soon as possible in advance of July 1, 2014. Pursuant to 199 IAC 14.9, filings that arrive after 3:30 PM may not receive a July 1, 2014, date stamp.

2. Filing Instructions

ETCs should use the following titles when filing the annual reports in the Board's EFS:

FCC Form 481 (High-cost support, low-income support)

Filing Title: FCC Form 481 Annual Report

Document Title: Section 54.313/54.422(a) Annual Report

FCC Form 690 (Mobility Fund Phase 1 support)

Filing Title: FCC Form 690 Annual Report

Document Title: Section 54.1009 Annual Report

It will not be necessary for ETCs to file a transmittal letter along with the reports. The Board's Records and Information Center will assign each filing an FER docket number.

3. Confidential Information

If a carrier considers any of the information in its Section 54.313 report to be confidential, the carrier shall file both a public and confidential version of the material using the Board's EFS according to the Board's rules at 199 IAC 14.12, along with a

request for confidential treatment pursuant to 199 IAC 1.9 and Iowa Code § 22.7. The Board understands that the FCC does not intend to protect the information required by § 54.422(a) or § 54.1009 from public disclosure. An ETC should only request confidential treatment of information it is also asking the FCC to protect from public disclosure.

ORDERING CLAUSES

IT IS THEREFORE ORDERED:

- On or before July 1, 2014, eligible telecommunications carriers
 receiving federal high-cost support and eligible telecommunications carriers receiving
 low-income support shall file their FCC Form 481 reports with the Utilities Board
 according to the instructions contained in this order and file those reports with the
 Federal Communications Commission and the Universal Service Administrative
 Company.
- On or before July 1, 2014, eligible telecommunications carriers
 receiving Mobility Fund Phase 1 support shall file their FCC Form 690 reports with

the Utilities Board according to the instructions contained in this order and file those reports with the Federal Communications Commission and the Universal Service Administrative Company.
